## Vendor Registration Fees:

Before June 15: \$50  
Late Registration: \$60

**Registration Deadline and Confirmation:** Registrations must be postmarked by June 15, 2009 for inclusion in the Norway Arts Festival program. Vending spaces will be assigned according to the order the registration forms are received. Early registration is encouraged.

**Vendor Check in and Set Up:** Food Vendors must check between 9-10 a.m. with the Festival Coordinator at the Food Court area which will be identified prior to the festival. Vendors must be set up and be ready for business with cars parked in assigned lots by 10 AM. Volunteers will be available to assist with set up, break down and parking vehicles.

**Display Space, Location, Vendor Hours & Trash Removal:** Vendors are responsible for their own trash removal and providing their own equipment, including a tent if applicable. Some picnic tables will be provided onsite in the Food Court. A single display space must be 10' x 10' unless other configurations are approved by the festival coordinator. Exhibits will be open from 10 a.m. until 4 p.m. as weather permits, and vendors are expected to be open for the entire day. You will be located in a food court which will be central to all Festival activities. The Norway Arts Festival Committee is working hard to revamp our new food court location.
